"The end-all of processing is the attainment of a goal, the goal of OT. One always processes the problems and difficulties of the pc, he does not process the process. Processes only assist in processing the pc. They will not do anything by themselves. Processes are a road map to the goal of OT, they are nothing in themselves. The target is the condition, the disabilities of the pc. How one achieves the eradication of these difficulties is secondary to the fact of their eradication. Scientology is a route attained after several thousand years of no attainment by Man and the route is important and valuable and must be travelled correctly, but the concern is the pc, not the route.

A new auditor can be adrift with his tools. He is uncertain as to what he is attacking. He should have reality on engrams, locks, key-ins, secondaries, the time track, the key buttons of Scientology such as Communication, Control and Havingness. Given an understanding of all these and the theory of Scientology itself he can almost pilot his way through a case with two-way comm. But two-way communication will not work if one doesn't understand all the above. So two-way communication is not conversation. The pc has had a few trillion years of that and it hasn't made him well, so two-way communication is a highly specialized thing, done with full understanding of the thetan, bank and body. Good two-way comm means participation by the pc.

Scientology is a precise commodity, something like engineering. A pc is a precise thing, part animal, part pictures and part God. We want the ability to handle things and the God, and the less unthinking responses in the pc the better off he will be. Therefore a PC WHO ISN'T COGNITING regularly is being processed beyond his ability to do and it is necessary to drop back downscale to find something he CAN DO.

The golden rule of processing is to find something the preclear CAN do and then to improve his ability to do it. At once you will have participation. The highest ability one pc had was to get drunk: a resolution of his case was entered upon by having him invent ways to get drunk."

HOW TO STRAIGHTEN OUT A GROUP

Extract from a radio broadcast on
7 February 1951

Raising Group Tone

Dianetics is the science of reason. In Group Dianetics we have been talking on the level of nations because people are wondering about atom bombs and the fate of existence, and we have stressed this point.

However, nations are not the only groups in the world. One group is like another group, a collection of individuals with certain goals and desires. I would like to tell you about how to straighten out a group and raise its survival value and general tone.

A strong man who is well and cheerful is much better able to survive than one who is sour on life. A person who survives is a person who has the greatest survival potential. It is measured by his general tone, his attitude toward life, his ability to cooperate with life and his native intelligence, as well as other factors. All men are not born equal. Some, for instance, have greater ability to execute their ideas.

All men are entitled to equal rights under law, if it is any kind of group. When a group denies individual rights it is far down on the tone scale. The individual needs to determine his own future, to conduct his own life, and so on. Russia has overlooked this.

The United States has overlooked to some slight degree the individual's necessity to be a part of his group. The group of the United States is not as strong and powerful a group, as groups go, as it is a strong and powerful number of individuals. Our stress is on the individual. Perhaps it is a little over stressed, but this does not mean that the individual is not entitled to equal rights under law. It means that he should be given more of something. An individual should have more say in the conduct of his nation and is entitled to a greater feeling of oneness with the other members of his group, and he is entitled to contribute to the group.

During the last war people were not allowed to contribute their skills to the country. The personnel placement failed badly. For instance, a trained engineer would ride a motorcycle to carry messages, or a boy who was really a good architect would pilot a plane. The inability of the individual to contribute to his group lowered his tone.

There seemed to be some belief on the part of the administration that the people were soft-headed and had to be protected. The news dispatches that came out led people to believe that the war was not very serious, but the people in the combat area knew it was not so good.

Every government does this out of some mistaken idea of security or effort to pick up the group tone.

The war neuroses turned up back of the battle lines, not in the battle lines. Those in actual action were not hysterical. A person in a supply depot would develop a war neurosis, and a soldier on the front lines would not go mad. He was contributing to his group.

There is an enormous group potential in every individual. Russia plays up to this group potential. It sells the group to the individual and tells the individual he is not important as himself. It is too heavy on the third dynamic. It says the group is all.

Man has a tremendous need to belong to a group, and people of the country cannot be prevented from contributing to the country. People who were given charity wanted to be able to work. They should have been permitted to contribute to the group, but they were not, and therefore they were very unhappy. The individual must be able to contribute to the group, and vice versa. One is not greater than the other. There is nothing wrong in our basic structure except that the group ideal has slacked off. We need to get democracy burnished up instead of talking about better forms of government. Some people were willing to consider that fascism was desirable and could be expected. They were willing to let the tone of the country drop into effect. They all have ideas about how this group should be run. They should be able to express their ideas, should have more direct representation, should be themselves the government. That is the way a democracy should work.

It is a simple thing to increase the tone of a country, without even clearing up its engrams. All you have to do is demonstrate the fact that the group has a mission and give each individual the right to contribute to the carrying out of this mission. In this way we could carry forward with an increased tone level.

But we should go back and find where these hidden pieces of information are:

Did J. P. Morgan sell us out as a nation? What about the Civil War? An entire part of this country is stuck in the Civil War. This engram should be run out.

"The address of Dianetics and Scientology is not to the ill, the insane or the criminal. It is effective in these fields. But its intention is toward the improvement of the able. Men who already can accomplish things can accomplish more. The problems of the society depend upon clear-thinking and sane men. Processing can bring about that state according to long experience.

Processing has now become relatively simple. The auditor first must understand the basic axioms of the subject and their meaning in processing. He must have a good grasp of his essential tools. He can gain this understanding in a few weeks if he is quick and intelligent. He must then be able to handle the techniques of application. These are effective and swift.

When one starts to handle primitive instincts in a human being, that human being sometimes has the sensation of having lived before. We know the instincts from distant times are there and we know where they are filed and we know how to change the record. It is relatively simple to call up in any human being the basic and underlying records which have haunted Man for generations. No matter how solidly he is repressing them, the instincts are there. When they are in sight and deintensified, he is able to relax, to be free, and to be effective.

The simplicity of the present techniques seems to belie the arduousness of their discovery. But they contain all the thousands of years of Man's search for what makes Man hate Man.

Dianetics and Scientology are no more than reason joining research in the humanities and research in the fields of energy and the physical sciences. Once this knowledge was joined, the answers were readily available.

Perhaps now it may be possible, in an overwrought world, to do something about the criminals, the insane, about war and the antisocial hatred Man feels for Man. Can we do something for the savage in civilized garb before he ruins this world and all Man? That is a question which the future must answer. I cannot do more than the work I have done and to publish and make available what has been done.

Every facility which I have and every knowledge which we have gained is at your disposal. It is at your disposal to improve you, to make crime a thing of yesterday, to banish war forever. But it is up to you."

What is the Freezone?

Bill Robertson in Frankfurt/Main originally coined the term Freezone in 1983, and the concept has spread throughout the world with thousands of people using and practicing the technology of Lafayette Ron Hubbard.

The biggest groups are in Europe and the US but there are many hundreds of small groups and individuals using and practicing the technology of Lafayette Ron Hubbard. The Freezone, by definition is less rigid and not bound as is the 'official' Church of Scientology.

The Freezone is made up of persons who have previously been members of the Church of Scientology but have either been thrown out and excommunicated for one reason or another or left on their own accord when they observed that the 'official' church was no longer practicing the original philosophy. Also people who have learned about the philosophy in the Freezone for the first time without the influence of the 'official' church.

What is Scientology

"The term SCIENTOLOGY is taken from the Latin word SCIO (knowing in the fullest meaning of the word) and the Greek word LOGOS (to study)"

Fundamentals of Thought - L Ron Hubbard

Scientology is that applied and workable philosophy developed by Lafayette Ron Hubbard during most of his life.

Scientology™ includes the understanding of life, its composition and potentialities. The application part of the philosophy includes activities which one can embark upon to improve one's life both in the spiritual sense as well as the physical.

The philosophy and the application of it is found in the many books he wrote and the many thousands of lectures he gave which are available on audio tapes and CDs.

The official body of Scientology is the Church of Scientology. The church is considered by many to have departed from the original philosophy as expounded by Lafayette Ron Hubbard. Instead they are thought to be pursuing a different agenda of altering the application of the philosophy to a point where it becomes unworkable and no longer achieves the aims set out for it by the founder.

What is the International Freezone Association?

The IFA (International Freezone Association) has been created to assist Scientologists and non-scientologists alike practice and pursue their chosen philosophy as developed by Lafayette Ron Hubbard.

The IFA has the purposes of preserving, protecting and promoting the original philosophy and technology of Ron Hubbard. As distinct to off shoots, changes and other altered versions of the same promoted by the current church and others.

It consists of members who may be simply individuals wishing to improve and enhance their life, or auditors (An auditor is a practitioner of the technology who listens and assists people to improve their life through various practical activities) or groups of auditors.

ACKNOWLEDGEMENT, something said or done to inform another that his statement or action has been noted, understood and received. “Very good,” “Okay,” and other such phrases are intended to inform another who has spoken or acted that his statement or action has been accepted. An **acknowledgement** also tends to confirm that the statement has been made or the action has been done and so brings about a condition not only of communication but of reality between two or more people. Applause at a theater is an **acknowledgement** of the actor or act plus approval. **Acknowledgement** itself does not necessarily imply an approval or disapproval or any other thing beyond the knowledge that an action or statement has been observed and is received. In signaling with the Morse code the receiver of a message transmits an R to the sender as a signal that the message has been received, which is to say **acknowledged**. There is such a thing as overacknowledgement and there is such a thing as **under-acknowledgement**. A correct and exact **acknowledgement** communicates to someone who has spoken that what he has said has been heard. An **acknowledgement** tends to terminate or end the cycle of a communication, and when expertly used can sometimes stop a continued statement or continued action. An **acknowledgement** is also part of the communication formula and is one of its steps. The Scientologist, sometimes, in using Scientologese abbreviates this to “**Ack**”; he “**acked**” the person. (LRH Def. Notes)

AFFINITY, 1. the feeling of love or liking for something or someone. **Affinity** is a phenomena of space in that it expresses the willingness to occupy the same place as the thing which is loved or liked. The reverse of it would be antipathy, “dislike” or rejection which would be the unwillingness to occupy the same space as or the unwillingness to approach something or someone. It came from the French, affinite, **affinity**, kindred, alliance, nearness and also from the Latin, affinis, meaning near, bordering upon. (LRH Def. Notes) **2.** the ability to occupy the space of, or be like or similar to, or to express a willingness to be something. (SH Spec 83, 6612C06) **3 .** the relative distance and similarity of the two ends of a communication line. (Dn 55!, p. 35) **4 .** emotional response; the feeling of affection or the lack of it, of emotion or misemotion connected with life. (HCOB 21 Jun 71 I) **5 .** the attraction which exists between two human beings or between a human being and another life organism or between a human being and mest or theta or the Supreme Being. It has a rough parallel in the physical universe in magnetic and gravitic attraction. The **affinity** or lack of **affinity** between an organism and the environment or between the theta and mest of an organism and within the theta (including entheta) of the organism brings about what we have referred to as emotions. (SOS Gloss) **6 .** in its truest definition which is coincidence of location and beingness, that is the ultimate in **affinity**. (9ACC-10, 5412CM20)

ARC:

A word made from the initial letters of Affinity, Reality and Communication which together are considered to equal understanding. ARC is pronounced as three letters A-R-C.

COMMUNICATION, 1 . the consideration and action of impelling an impulse or particle from source point across a distance to receipt point with the intention of bringing into being at the

receipt point a duplication and understanding of that which emanated from the source point. (HCOB 5 Apr 73) **2** . the first and most basic definition of any part of **communication** is that **communication** or any part thereof is a consideration. As duplication is a consideration, **communication** is possible to the degree that the preclear can freely make considerations. (COHA, pp. 170-171) **3** . the operation, the action, by which one experiences emotion and by which one agrees. **Communication** is not only the modus operandi, it is the heart of life and is by thousands of per cent the senior in importance to affinity and reality. (PAB 1) **4** . any ritual by which effects can be produced and perceived. Thus a letter, a bullet, the output of theta "flitter" are all, to us, **communication**. (PAB 4) **5** . the ability to translate sympathy or some component of sympathy from one terminal to another terminal. (Spr Lect 5, 5303CM25) **6** . an interchange of energy from one beingness to another in the thetan, and in Homo sapiens, **communication** is known as perception. (Scn 8- 8008, p. 21) **7** . the handling of particles, of motion. (PAB 1) **8** . the interchange of perception through the material universe between organisms or the perception of the material universe by sense channels. (Scn 0-8, p. 83) **9** . the interchange of ideas across space. (Scn 0-8, p. 36) **10** . the use of those sense channels with which the individual contacts the physical universe. (DAB, Vol. II, p. 218)

REALITY, 1. is, here on earth, agreement as to what is. This does not prevent barriers or time from being formidably **real**. It does not mean either that space, energy or time are illusions. It is as one knows it is. (COHA, p. 249) **2** . That sequence which can, we say this person is suffering from **reactive conduct**. He has a **reactive** mind. In other words, his association has become too blatantly in error for him any longer


